

## **Broadcasting Decision CRTC 2005-507**

Ottawa, 20 October 2005

Kenneth Clarke Odland, on behalf of a corporation to be incorporated Wolseley, Saskatchewan

Application 2005-0304-6 Public Hearing in the National Capital Region 15 August 2005

#### English-language low-power tourist FM radio station in Wolseley

- 1. The Commission **approves** the application by Kenneth Clarke Odland, on behalf of a corporation to be incorporated, for a broadcasting licence to operate an English-language low-power tourist FM radio programming undertaking in Wolseley, Saskatchewan.
- 2. The new station will broadcast a year-round tourist information service consisting of pre-recorded messages promoting tourist attractions and community events. It will also broadcast weather bulletins and forecasts, reports on highway surface conditions and other travel-safety information.
- 3. The station will operate at 93.1 MHz (channel 226LP) with an effective radiated power of 43.7 watts.
- 4. The Commission received several interventions in support of this application.
- 5. The licence will expire 31 August 2012 and will be subject to the **conditions** set out in the appendix to this decision.
- 6. The Department of Industry (the Department) has advised the Commission that, while this application is conditionally technically acceptable, it will only issue a broadcasting certificate when it has determined that the proposed technical parameters will not create any unacceptable interference with aeronautical NAV/COM services.
- 7. The Commission reminds the applicant that, pursuant to section 22(1) of the *Broadcasting Act*, no licence may be issued until the Department notifies the Commission that its technical requirements have been met, and that a broadcasting certificate will be issued.
- 8. Given that the technical parameters approved in this decision are for a low-power unprotected FM service, the Commission also reminds the applicant that it will have to select another frequency if the Department so requires.

- 9. Furthermore, the licence for this undertaking will only be issued once the applicant has:
  - satisfied the Commission, with supporting documentation, that an eligible Canadian corporation has been incorporated in accordance with the application in all material respects; and
  - informed the Commission in writing that it is prepared to commence operations.
- 10. The undertaking must be operational at the earliest possible date and in any event no later than 24 months from the date of this decision, unless a request for an extension of time is approved by the Commission before 20 October 2007. In order to ensure that such a request is processed in a timely manner, it should be submitted at least 60 days before that date.

## Appendix to Broadcasting Decision CRTC 2005-507

### **Conditions of licence**

- 1. The licensee shall use the station solely for the purpose of providing pre-recorded messages promoting tourism, and reports on weather and road conditions.
- 2. The licensee shall not broadcast more than six minutes of advertising material per clock hour.
- 3. The licensee shall not broadcast musical selections, except as incidental background music.
