### 1. **Goderich, Ontario** **Application No. 2007-1602-9**

Application by **2079966 Ontario Limited** to amend the licence of the English-language commercial radio programming undertaking CIYN-FM Kincardine, Ontario.

The licensee proposes to add an FM transmitter at Goderich, Ontario to broadcast the programming of CIYN-FM, in order to serve the population of Goderich.

The transmitter would operate on frequency 99.7 MHz (channel 259A) with an effective radiated power of 750 watts (non-directional antenna/effective antenna height of 89 metres).

The Commission notes that it approved a transmitter in Goderich in Broadcasting Decision CRTC 2005-68, 17 February 2005, *Adult Classic Hit FM radio station in Kincardine, with transmitters in Goderich and Port Elgin*. It further notes that the licensee did not meet the requirements of this decision for the transmitter, wherein it did not become operational nor was a request for an extension of time to commence operation received at the Commission within the given time frame. Consequently, the authority granted in Broadcasting Decision CRTC 2005-68 for the operation of the transmitter became null and void effective 17 February 2007.

The licensee reminds the Commission that a transmitter was originally approved for Goderich but due to a dispute with the owners of the tower, it was unable to become operational in the required time frame.
