Application by **TFG Communications Inc.** to amend the licence of the English-language commercial specialty FM radio programming undertaking CJEF-FM Saint John.

The licensee proposes to delete the following conditions of licence:

The station shall be operated within the Specialty format as defined in *A review of certain matters concerning radio*, Public Notice CRTC 1995-60, 21 April 1995, and in *Revised content categories and subcategories for radio*, Public Notice CRTC 2000-14, 28 January 2000, as amended from time to time.

The licensee shall devote more than 50% of each broadcast week to the broadcast of spoken word programming.

The licensee shall broadcast, in any broadcast week, no more than 40% hit material as defined in *Revised policy on the use of hits by English-language FM radio stations*, Public Notice CRTC 1997-42, 23 April 1997.

The licensee is now proposing to offer a blend of Alternative Rock, Hip Hop and R&B musical selections, targeting the 18-34 year old demographic.

The licensee also proposes that at least 50% of all musical selections from content category 2 (Popular Music) played both during the broadcast week and between 6 a.m. and 6 p.m. Monday through Friday be devoted to Canadian selections played in their entirety. It also indicates that it would accept as a condition of licence to devote 15% of its musical selections to local (maritime) music.
