Application by **Rawlco Radio Ltd.** (Rawlco) to amend the licence of the English-language commercial specialty FM radio programming undertaking in Calgary, Alberta, approved in *Folk/Acoustic Specialty FM radio station in Calgary*, Broadcasting Decision CRTC 2006-322, 2 August 2006.

The licensee proposes to amend the licence by changing the frequency from 100.3 MHz (channel 262C) to 97.7 MHz (channel 249C1).

The licensee also proposes to change the authorized contours by increasing the average effective radiated power from 19,000 watts to an effective radiated power of 100,000 watts (non-directional antenna), by increasing the effective antenna height to 298.6 metres and by relocating the transmitter.

The licensee states that the proposed technical parameters would improve the signal of the station.

The authorized contours of the station will be increased significantly resulting from the proposed technical changes.



Rawlco indicates that at the present time 97.7 MHz is used by CAB-K Broadcasting Ltd. (CAB-K) for its station CKLJ-FM Olds, Alberta which operates with an effective radiated power of 13,000 watts (channel 249B) and represents an under-utilized use of the frequency spectrum.

Rawlco also indicates that CAB-K has agreed to change its frequency from 97.7 MHz (channel 249B) to 96.5 MHz (channel 243B) which results in the overall best use of the frequency spectrum.

The Commission notes that CAB-K has also filed an application (2007-0517-1) in this context which is also announced in this public notice.

2. Olds, Alberta Application No. 2007-0517-1

Application by **CAB-K Broadcasting Ltd.** (CAB-K) to amend the licence of the commercial radio programming undertaking CKLJ-FM Olds, Alberta.

The licensee proposes to amend the licence by changing the frequency from 97.7 MHz (channel 249B) to 96.5 MHz (channel 243B).

The licensee also proposes to change the authorized contours by increasing the effective radiated power from 13,000 to 35,000 watts (non-directional antenna) and by increasing the effective antenna height to 124.5 metres.

The authorized contours of the station will be increased which will increase significantly the population within the station's overall service area.

The applicant is requesting permission to simulcast the programming of CKLJ-FM on the frequency 97.7 MHz and 96.5 MHz for a period of three months from the date of implementation of the proposed technical changes.

The applicant advised that Rawlco Radio Ltd. (Rawlco) asked it to consider changing its

frequency for CKLJ-FM which Rawlco stated would result in the overall best use of the frequency spectrum. CAB-K noted that it is entering into this change in the spirit of cooperation with another Canadian broadcaster. CAB-K further stated that its listeners in its rural service area will benefit from improved reception.

The Commission notes that Rawlco Radio Ltd. has filed an application (2007-0516-3) to amend the broadcasting licence of its commercial specialty FM radio station in Calgary approved in *Folk/Acoustic Specialty FM radio station in Calgary*, Broadcasting Decision CRTC 2006-322, 2 August 2006, by changing the frequency from 100.3 MHz (channel 262C) to 97.7 MHz (channel 249C1) and for authority to change the authorized contours by increasing the average effective radiated power from 19,000 watts to an effective radiated power of 100,000 watts (non-directional antenna), by increasing the effective antenna height to 298.6 metres and by relocating the transmitter.

This application is also announced in this Public Notice.
