## **Telecom Decision CRTC 2008-95**

# Bell Aliant Regional Communications, Limited Partnership – Application for forbearance from the regulation of business local exchange services

Reference: 8640-B54-200809767

In this Decision, the Commission approves Bell Aliant's request for forbearance from the regulation of business local exchange services in the exchange of Goderich, Ontario, effective 27 October 2008.

#### Introduction

- 1. The Commission received an application by Bell Aliant Regional Communications, Limited Partnership (Bell Aliant), dated 15 July 2008, in which the company requested forbearance from the regulation of business local exchange services<sup>1</sup> in the exchange of Goderich, Ontario.
- 2. The Commission received submissions and/or data regarding Bell Aliant's application from Huron Telecommunications Co-operative Limited (HuronTel). The public record of this proceeding, which closed on 21 August 2008, is available on the Commission's website at <a href="https://www.crtc.gc.ca">www.crtc.gc.ca</a> under "Public Proceedings."

#### Commission's analysis and determinations

3. The Commission has assessed Bell Aliant's application based on the local forbearance test set out in Telecom Decision 2006-15, as amended by the Governor in Council's *Order Varying Telecom Decision CRTC* 2006-15, P.C. 2007-532, 4 April 2007 (modified Telecom Decision 2006-15), by examining the four criteria set out below.

#### a) Product market

- 4. The Commission received no comments with respect to Bell Aliant's proposed list of business local exchange services.
- 5. The Commission notes that Bell Aliant is seeking forbearance for 34 tariffed business local exchange services. The Commission also notes that in Telecom Decision 2007-70 it considered 32 of these services to be appropriate for forbearance.
- 6. The Commission notes that Bell Aliant is seeking forbearance for item 515, 900 Service; however, the Commission notes that the portion of this service that it can forbear from regulating is item 515.3(k), 900 Call Denial/Blocking, as indicated in Telecom Decision 2007-70-2. Accordingly, the Commission considers 900 Call Denial/Blocking to be appropriate for forbearance.

In this Decision, "business local exchange services" refers to local exchange services used by business customers to access the public switched telephone network and any associated service charges, features, and ancillary services.



- 7. The Commission considers that the remaining service, Fax Line, falls within the definition of local exchange services as set out in Telecom Public Notice 2005-2.
- 8. The list of approved services is set out in the Appendix to this Decision.

#### b) Competitor presence test

- 9. The Commission notes that for the exchange of Goderich, information provided by the parties indicates that there is, in addition to Bell Aliant, one other independent facilities-based, fixed-line telecommunications service provider<sup>2</sup> that offers local exchange services in the market and is capable of serving at least 75 percent of the number of business local exchange service lines that Bell Aliant is capable of serving.
- 10. Accordingly, the Commission determines that the exchange of Goderich meets the competitor presence test.

#### c) Competitor quality of service (Q of S) results

- 11. The Commission notes that Bell Aliant submitted competitor Q of S results for the period of December 2007 to May 2008.
- 12. The Commission has reviewed Bell Aliant's competitor Q of S results and finds that for one competitor it provided services that were below the Q of S standard; however, in that case there was only one data point for the six-month period. The Commission notes that in Telecom Decision 2007-58 it considered that where there are only a few data points during a six-month period, there is insufficient data to make a finding that a company has consistently provided below-standard Q of S.
- 13. The Commission notes that Bell Aliant has demonstrated that during this six-month period it
  - i) met, on average, the Q of S standard for each indicator set out in Appendix B of modified Telecom Decision 2006-15, as defined in Telecom Decision 2005-20, with respect to the services provided to competitors in its territory; and
  - ii) did not consistently provide any of those competitors with services that were below those Q of S standards.
- 14. Accordingly, the Commission determines that Bell Aliant meets the competitor Q of S criterion for this period.

#### d) Communications plan

15. The Commission has reviewed Bell Aliant's draft communications plan and is satisfied that it meets the information requirements set out in modified Telecom Decision 2006-15. The Commission **approves** the proposed communications plan and directs Bell Aliant to provide the resulting communications materials to its customers in both official languages, where appropriate.

#### Other matters

- 16. The Commission notes that HuronTel, the only facilities-based, fixed-line telecommunications service provider capable of serving at least 75 percent of the number of business local exchange service lines that Bell Aliant is capable of serving in the exchange of Goderich, submitted that it should be allowed to benefit from the 18-month grace period for providers with fewer than 20,000 local exchange services customers in Canada, as set out in paragraph 523 of modified Telecom Decision 2006-15.
- 17. The Commission also notes that Bell Aliant did not dispute HuronTel's claim that it has fewer than 20,000 local exchange services customers in Canada, nor did it dispute HuronTel's submission that it started offering local exchange services in the exchange of Goderich on 27 April 2007.
- 18. The Commission is satisfied that HuronTel meets the criterion of paragraph 523 of modified Telecom Decision 2006-15 and that it started offering local exchange services in the exchange of Goderich on 27 April 2007. Accordingly, the Commission determines that forbearance from the regulation of business local exchange services in that exchange shall therefore become effective as of 27 October 2008.

#### Conclusion

- 19. The Commission determines that Bell Aliant's application regarding the exchange of Goderich, Ontario, meets all the local forbearance criteria set out in modified Telecom Decision 2006-15.
- 20. Pursuant to subsection 34(1) of the *Telecommunications Act* (the Act), the Commission finds as a question of fact that to refrain from exercising its powers and performing its duties, to the extent specified in modified Telecom Decision 2006-15, in relation to the provision by Bell Aliant of business local exchange services listed in the Appendix and future services that fall within the definition of local exchange services set out in Telecom Public Notice 2005-2 as they pertain to business customers only, in the exchange of Goderich, would be consistent with the Canadian telecommunications policy objectives set out in section 7 of the Act.
- 21. Pursuant to subsection 34(2) of the Act, the Commission finds as a question of fact that these business local exchange services are subject to a level of competition in this exchange sufficient to protect the interests of users of these services.
- 22. Pursuant to subsection 34(3) of the Act, the Commission finds as a question of fact that to refrain from exercising its powers and performing its duties, to the extent specified in modified Telecom Decision 2006-15, in relation to the provision by Bell Aliant of these business local exchange services would be unlikely to impair unduly the continuance of a competitive market for these services in this exchange.
- 23. In light of the above, the Commission **approves** Bell Aliant's application for forbearance from the regulation of the local exchange services listed in the Appendix and future services that fall within the definition of local exchange services set out in Telecom Public Notice 2005-2, as they pertain to business customers only, in the exchange of Goderich, subject to the powers and

duties that the Commission has retained as set out in modified Telecom Decision 2006-15. This determination takes effect on 27 October 2008. The Commission directs Bell Aliant to file revised tariff pages with the Commission by 27 October 2008.
