Changes to procedure

- 1. With this notice, the Commission revises certain procedural dates established in Compliance and Enforcement and Telecom Notice of Consultation 2017-4.
- 2. On 20 January 2017, the Commission received a procedural request from Rogers Communications Canada Inc. to extend the filing deadlines for interventions and final submissions originally set out in the above-referenced notice. Support for this request was received by the Commission from Bell Canada, MTS Inc., Quebecor Media Inc., Saskatchewan Telecommunications, and TELUS Communications Company.
- 3. These companies indicated that the resources required to work on the submissions for the proceeding initiated by Compliance and Enforcement and Telecom Notice of Consultation 2017-4 are also engaged in the current next-generation 9-1-1 proceeding and in providing the CRTC Interconnection Steering Committee (CISC) deliverables to the Commission pursuant to Compliance and Enforcement and Telecom Regulatory Policy 2016-442.
- 4. In the circumstance, the Commission considers the request to extend the filing deadlines to be reasonable.

¹ The next-generation 9-1-1 proceeding was initiated with the issuance of Telecom Notice of Consultation 2016-116. The oral public hearing associated with that notice was held in mid-January 2017; parties to that process had until 31 January 2017 to file their final submissions with the Commission.



5. Accordingly, the Commission revises the dates for the filing of documents in this proceeding so that interventions are due by 1 March 2017 and final submissions are due by 15 March 2017.²
