- 2. The licensees shall adhere to the **conditions** set out in Broadcasting Regulatory Policy 2009-62, with the exception of condition 8 for CFFM-FM-2 Quesnel, as well as to the **conditions** set out in the broadcasting licence for each undertaking.
- 3. The Commission received interventions supporting the application by NBCL.

Reminders

- 4. Pursuant to section 22 of the *Broadcasting Act*, the broadcasting licences renewed in this decision will cease to have any force or effect if the broadcasting certificates issued by the Department of Industry lapse.
- 5. Vista must fulfill all the tangible benefits resulting from the applications approved in Broadcasting Decision 2012-577 and by decision letter dated 5 July 2012 (application 2012-0182-1).

Cultural diversity

6. The Commission expects the licensees to reflect the cultural diversity of Canada in their programming and employment practices.

Encouragements

Employment equity

- 7. Because NBCL and Vista are subject to the *Employment Equity Act* and file reports with the Department of Human Resources and Skills Development, their employment equity practices are not examined by the Commission.
- 8. In accordance with Public Notice 1992-59, the Commission encourages the remaining licensees to consider employment equity issues in their hiring practices and in all other aspects of their management of human resources.

Local programming

9. The Commission encourages Vista to seek out opportunities to increase the amount of local programming broadcast on CFFM-FM-2 to ensure the local community in Quesnel is well served.
