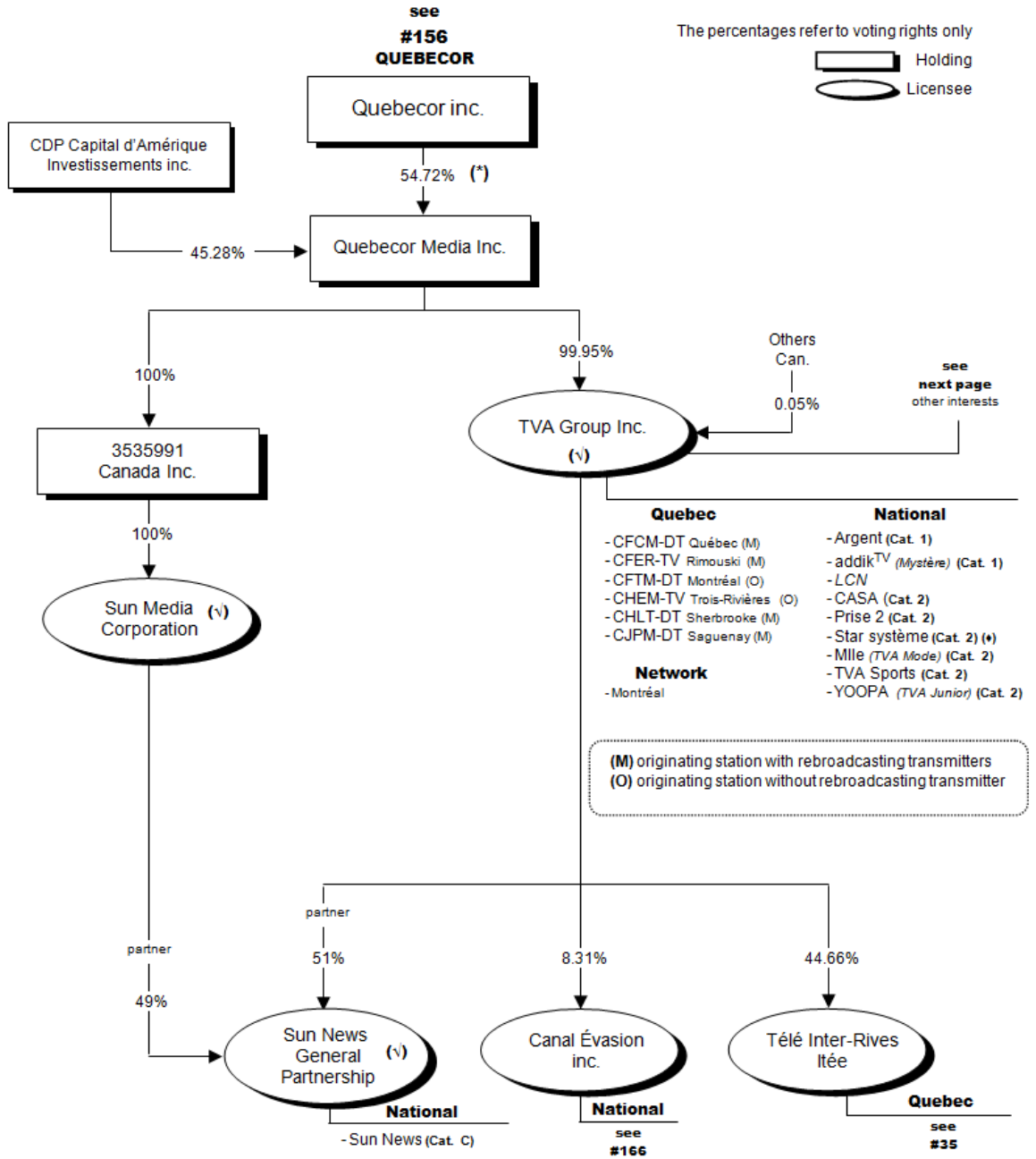

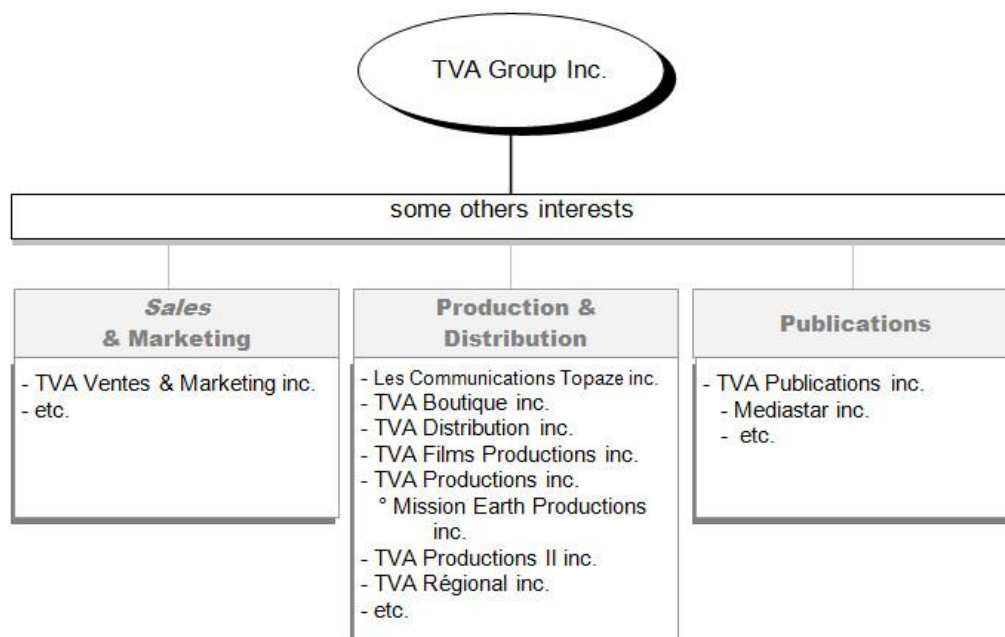

UPDATE

Update – 2012-04-23 – Quebecor Media Inc. /Quebecor Média inc. changed its name to Quebecor Media Inc. / Québecor Média inc.

CRTC 2012-238 - approved the acquisition by Shaw Media Global Inc. of the assets of the Specialty Category B service Mystery, through the acquisition of the units held by TVA Group Inc. in Mystery Partnership.

CRTC 2012-239 - approved the acquisition by Shaw Media Global Inc. of assets of the Specialty Category B service The Cave, through the acquisition of the units held by TVA Group Inc. in Men TV General Partnership.

CRTC 2012-282 – approved the revocation of the licence issued to TVA Group Inc. for the radio network associated with CFTM-FM Montréal.

Quebecor Media Inc. holds the following:

- 100% of 3535991 Canada Inc., which in turn holds 100% of Sun Media Corporation, and
- 99.95% of TVA Group Inc. The other 0.05% is held by other Canadian shareholders

TVA Group Inc. is the partner holding 51% of the units in Sun TV News General Partnership. Sun Media Corporation is the other partner holding 49% of the units in Sun TV News General Partnership.
