### 1. **Across Canada** **Application No. 2006-1541-1**

Application by **Bell ExpressVu Inc., (the general partner), and BCE Inc. and 4119649 Canada Inc. (partners in BCE Holdings G.P., a general partnership that is the limited partner), carrying on business as Bell ExpressVu Limited Partnership** (ExpressVu) to amend the licence of its national direct-to-home satellite distribution undertaking.

The licensee proposes to amend its licence by adding a condition of licence that would authorize ExpressVu to distribute on a digital basis the audio programming services offered by either or both of Canada's two satellite subscription radio undertakings.

The licensee proposes the following condition of licence:

The licensee is authorized to distribute at its option, the audio programming service of one or more licensed satellite subscription radio undertakings on a digital basis.

The licensee notes that approval of this condition of licence would assist the satellite subscription radio undertakings to deliver the benefits to Canadian artists and consumers that were set out in their application.

ExpressVu also states that approval of this condition of licence has been granted for a number of Class 1 broadcasting distribution undertakings for various locations throughout Ontario, Quebec, New Brunswick, and Newfoundland and Labrador, and would allow ExpressVu to maintain parity with competing cable distributors.
