Applications by **Radio Rimouski inc.** to amend the licence of the French-language commercial radio programming undertaking CFYX-FM Rimouski, Quebec.

The licensee proposes to add two FM transmitters at Amqui, Quebec and Edmundston, New Brunswick to broadcast the programming of CFYX-FM Rimouski, Quebec in order to adequately serve the population of Amqui and of Edmundston.

The transmitter at Amqui would operate on frequency 92.7 MHz (channel 224A) with an average effective radiated power of 280 watts (maximum effective radiated power of 900 watts/effective antenna height 202.6 metres).

The transmitter at Edmundston would operate on frequency 97.3 MHz (channel 247LP) with an average effective radiated power of 1.4 watts (maximum effective radiated power of 6.6 watts/effective antenna height 162.9 metres).
