Application by the **Canadian Broadcasting Corporation** to amend the licence of the radio programming undertaking CBH-FM Halifax, Nova Scotia.

The licensee proposes to add an FM transmitter at Yarmouth, Nova Scotia to broadcast its programming service Radio Two originating from CBH-FM Halifax in order to serve the population of Yarmouth.

The transmitter would operate on frequency 98.5 MHz (channel 253B) with an average effective radiated power of 19,900 watts (maximum effective radiated power 48,200 watts/effective antenna height of 139.5 metres).
