Application by **International Harvesters for Christ Evangelistic Association Inc.** to amend the licence of the English-language specialty FM radio programming undertaking CJLU-FM Halifax, Nova Scotia.

The licensee proposes to add an FM transmitter at Wolfville, Nova Scotia to broadcast the programming of CJLU-FM Halifax in order to serve the population of Wolfville.

The transmitter would operate on frequency 88.3 MHz (channel 202A) with an average effective radiated power of 175 watts (maximum effective radiated power 1,000 watts/effective antenna height of 187 metres).

In an effort to provide a religious FM radio service to the people of the Annapolis Valley who have a religious persuasion, the licensee is proposing the addition of a transmitter at Wolfville.

The transmitter would operate on the frequency 103.5 MHz (channel 278A1) with an effective radiated power of 250 watts (non-directional antenna/effective antenna height of 6.6 metres).
