Application by **CTV Limited** to amend the licence of the English-language commercial radio programming undertaking (CKPT-FM) approved in *CKPT Peterborough – Conversion to FM band*, Broadcasting Decision CRTC 2007-99, 23 March 2007.

The licensee proposes to amend the licence by changing the frequency from 99.3 MHz (channel 257B) to 99.7 MHz (channel 259B).

The licensee also proposes to amend the authorized contours by decreasing the average effective radiated power from 5,700 watts to 3,700 watts and by decreasing the effective antenna height (maximum effective radiated power 11,000 watts/effective antenna height 75.3 metres).

The Commission notes that there will be a minor change to the authorized contours resulting from the proposed technical changes.

The licensee advises that the proposed changes will resolve third adjacent interference with the Canadian Broadcasting Corporation's station CBCP-FM which operates on 98.7 MHz (channel 254B) in Peterborough.
