Application by **Astral Media Radio Inc.** relating to the licence of the French-language FM radio programming undertaking CJMM-FM Rouyn-Noranda, Quebec.

The licensee proposes to amend the licence of CJMM-FM Rouyn-Noranda by changing the authorized contours of its transmitter CJMM-FM-1 at La Sarre by increasing the effective radiated power from 349 watts to 1,904 watts. All other technical parameters remain unchanged.

The licensee states that the current effective radiated power of CJMM-FM-1 is inferior to the other competitive FM radio stations serving La Sarre. The licensee also wishes to increase the quality of the signal and include surrounding communities.

Application by **Access Communications Co-operative Limited** (Access) to amend the Class 1 licence for its cable broadcasting distribution undertaking (BDU) serving Regina.

Access proposes to replace its current condition of licence, which reads:

The licensee is authorized to distribute, at its option, WBZ-TV (CBS), WHDH-TV (NBC), WCVB-TV (ABC), WFXT (FOX), and WGBH-TV (PBS) Boston, Massachusetts, as part of the basic service.

With the following condition of licence:

The licensee is authorized to distribute, at its option, WCCO-TV (CBS) Minneapolis, Minnesota, and WHDH-TV (NBC), WCVB-TV (ABC), WFXT (FOX) and WGBH-TV (PBS) Boston, Massachusetts, as part of the basic service. Alternatively, for each network signal, the licensee may distribute the signal of a different affiliate of the same network located in the same time zone as that of the licensed area and included in the *Lists of eligible satellite services*, as amended from time to time.

Access states that the amendment sought would provide it with similar flexibility to that granted to other BDUs.
