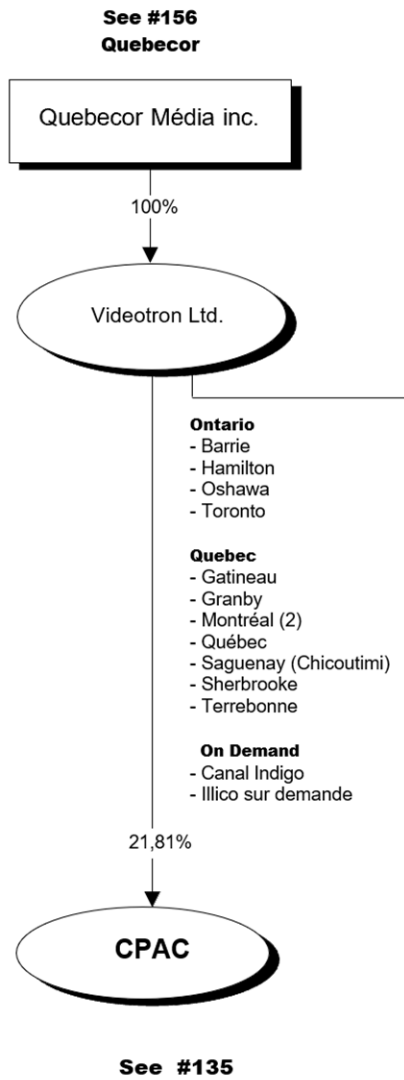

CRTC 2017-453 – approved, as part of a corporate reorganization, the acquisition by Videotron Ltd. of the assets of Videotron G.P.

Administrative Decision CRTC L2022-0025 – 2022-06-30 – approved a change in ownership and effective control of 2251723 Ontario Inc. through the transfer of all of the issued & outstanding shares of VMedia Inc. to Quebecor Media Inc. (2022-0184-6)

Administrative Decision CRTC L 2022-0041 – 2022-09-07 – approved a change in ownership of 2251723 Ontario Inc. through the transfer of all of the issued & outstanding shares of VMedia Inc. to Videotron Ltd. (2022-0440-3)

CRTC 2024-96 – revocation of the licence issued to 2251723 Ontario Inc. for the terrestrial broadcasting distribution undertaking serving Montréal. This undertaking is now exempt from holding a licence.

CRTC 2024-323 – approved, as part of a corporate reorganization, the acquisition by Freedom Mobile Inc. of the assets of the terrestrial broadcasting distribution undertakings and of the national on-demand service held by 2251723 Ontario Inc. **Note:** The transaction closed on January 1, 2025.

CRTC 2025-308 – approved a transfer of the assets of terrestrial broadcasting distribution undertakings serving the Greater Toronto Area and the cities of Barrie, Hamilton-Niagara, and Oshawa, as well as the assets of its national ondemand service from Freedom Mobile to Videotron. **Note:** The transaction closed on December 31, 2025.

CRTC 2025-309 - revocation of the licence for the on-demand service formerly known as Freedom Mobile, operated by Videotron Ltd.
