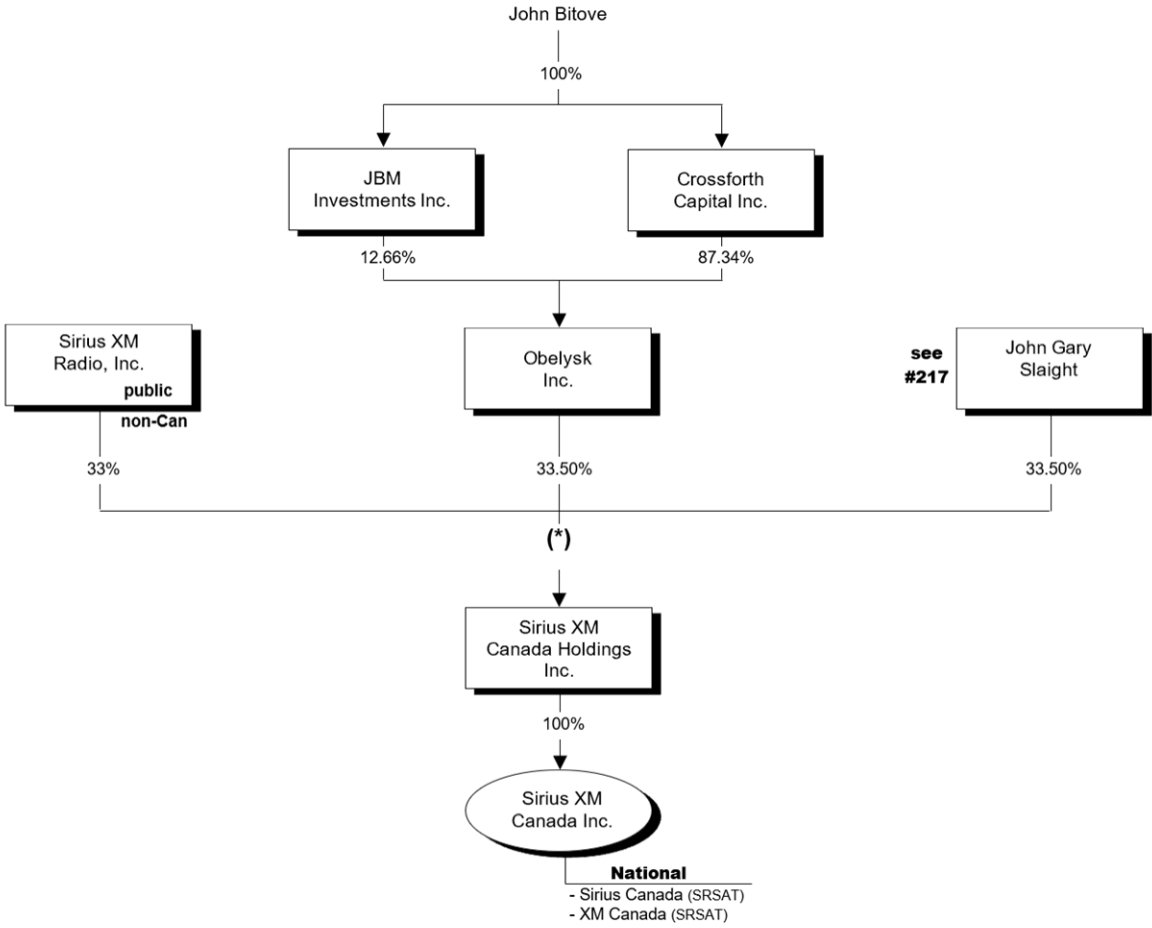

## **UPDATE**

**Name change** – 2013-01-15 - of Canadian Satellite Radio Holdings Inc. to Sirius XM Canada Holdings Inc.

**Update** – 2013-05-13 – of Sirius XM Canada Holdings Inc.'s shareholding.

**CRTC 2017-114** – approved a change in the ownership structure of Sirius XM Canada Inc., subject to certain conditions and modifications. **NOTE: Conditions have been met and transaction has been reflected**

**Update** – 2020-07-15 – of Obelysk Media Inc.'s shareholding.

**Administrative Decision CRTC L2022-0053** – 2022-11-01 – approved a change in ownership of Sirius XM Canada Inc. through the transfer of the shares held by Slight Communications Inc. (SCI) in Sirius XM Canada Holdings Inc. to the Estate Trust of John Allan Slight, which is controlled by John Gary Slight, Gregory Allan Slight and David Coriat, trustees of the Estate Trust. John Gary Slight and Gregory Allan Slight are, combined, entitled to a 50 per cent share of the corporation estate as beneficiaries of the Estate Trust. In addition, as two of the three trustees, they are empowered to administer the portion of the estate set aside for the other beneficiaries. They both beneficially own SCI's voting shares. **Update** – 2023-04-12 – on 12 August 2021, Obelysk Media Inc. changed name to Obelysk Inc.

**Administrative Decision CRTC L2024-0044** – 2024-11-01 – Approved an intra-corporate reorganization of Sirius XM Canada Inc.'s (Sirius) parent company, Sirius XM Canada Holdings Inc., which involves transferring all voting shares (Class A, 33.5%) held by Slight Communications Inc, a corporation controlled by the Estate Trust of John Allan Slight, to John Gary Slight, a beneficiary.

Sirius XM Canada Inc. is a licensee and is 100% held by Sirius XM Canada Holdings Inc.

Sirius XM Canada Holdings Inc. is controlled by its board of directors and is held as follows:

- 33.50% by Obelysk Inc. which in turn is held as follows
  - 87.34% by Crossforth Capital Inc. and
  - 12.66% by JBM Investments Inc.(These 2 corporations are 100% held and controlled by Mr. John Bitove)
- 33.50% by John Gary Slaight, and
- 33.00% by Sirius XM Radio, Inc., a public non-Canadian corporation
