UPDATE

CRTC 2019-237 – approved the conversion of CHCM Marystown from the AM to the FM band.

CRTC 2019-253 – approved the acquisition by Stingray Radio Inc. of the assets of the radio station CHOO-FM Drumheller from Golden West Broadcasting Ltd. (2019-0071-2)

NOTE: the closing of the transaction occurred on 26 August 2019 and the transaction has been reflected.

CRTC 2019-430 – approved the application by Stingray Group Inc. for a broadcasting licence to operate the currently exempt, national, French-language discretionary service PalmarèsADISQ as a licensed discretionary service.

CRTC 2020-53 – approved the acquisition by Stingray Radio Inc. of the assets of the radio stations CIXL-FM Welland and CKYY-FM Welland from R.B. Communications Ltd. **NOTE: The transaction will not be implemented – NULL & VOID.**

CRTC 2020-98 – approved a broadcasting licence to operate the currently exempt, national discretionary service Stingray Hits.
