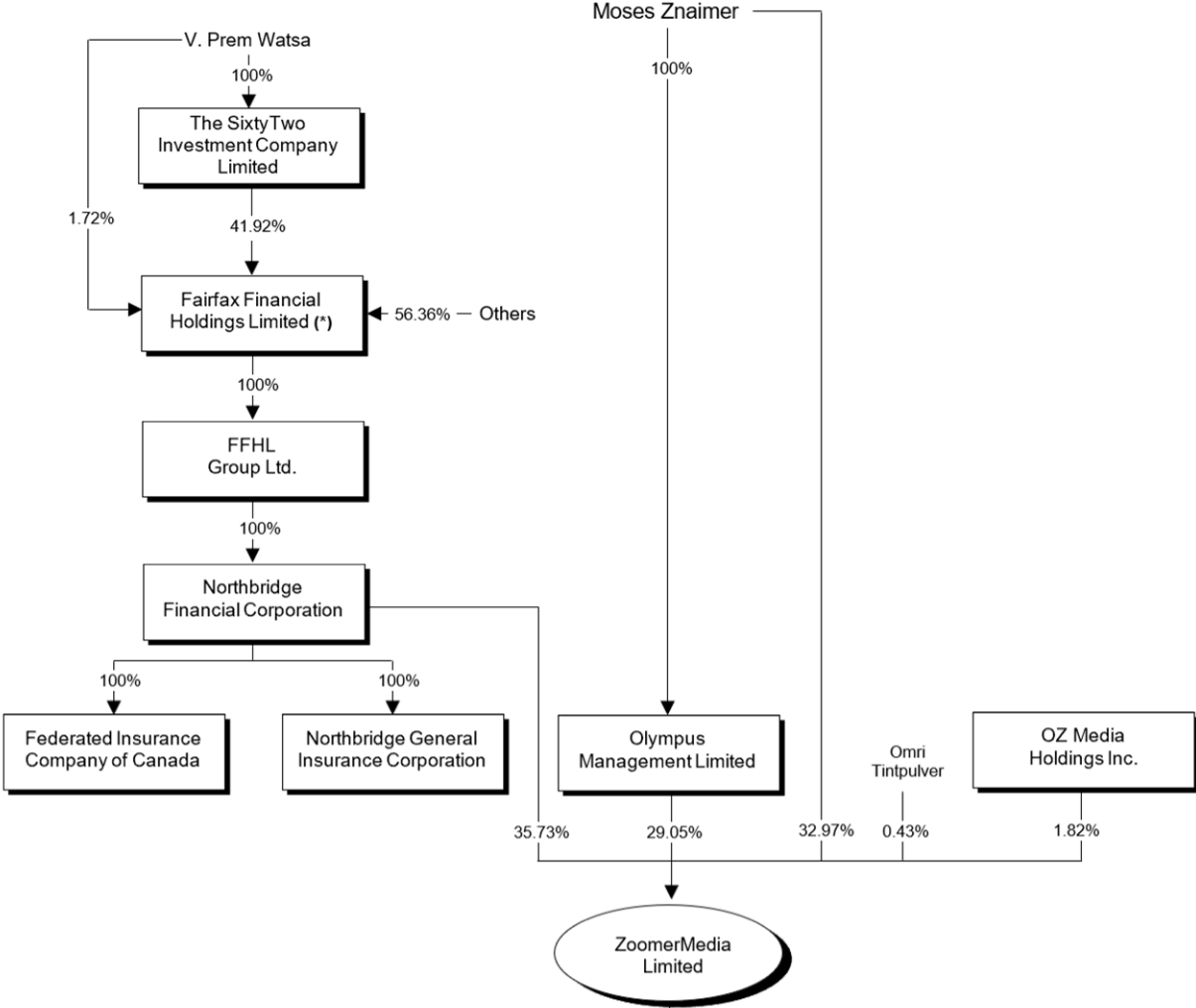

### OWNERSHIP

ZoomerMedia Limited is held as follows:

- 29.05% by Olympus Management Limited which in turn is 100% held by Moses Znaimer
- 0.43% by Omri Tintpuver
- 35.73% by Northbridge Financial Corporation (see the corporate structure below)
- 32.97% by Moses Znaimer
- 1.82% by OZ Media Holdings Inc.

The corporate structure of Northbridge General Insurance Corporation, Federated Insurance Company of Canada and Northbridge Financial Corporation, is as follows:

Federated Insurance Company of Canada and Northbridge General Insurance Corporation are 100% held by Northbridge Financial Corporation. In turn, Northbridge Financial Corporation is 100% held by FFHL Group Ltd. which in turn is 100% held by Fairfax Financial Holdings Limited.

Fairfax Financial Holdings Limited is controlled by V. Prem Watsa and is held as follows:

- 56.36% by other shareholders
- 41.92% by The Sixty-Two Investment Company Limited which in turn is 100% held by V. Prem Watsa and
- 1.72% by V. Prem Watsa
