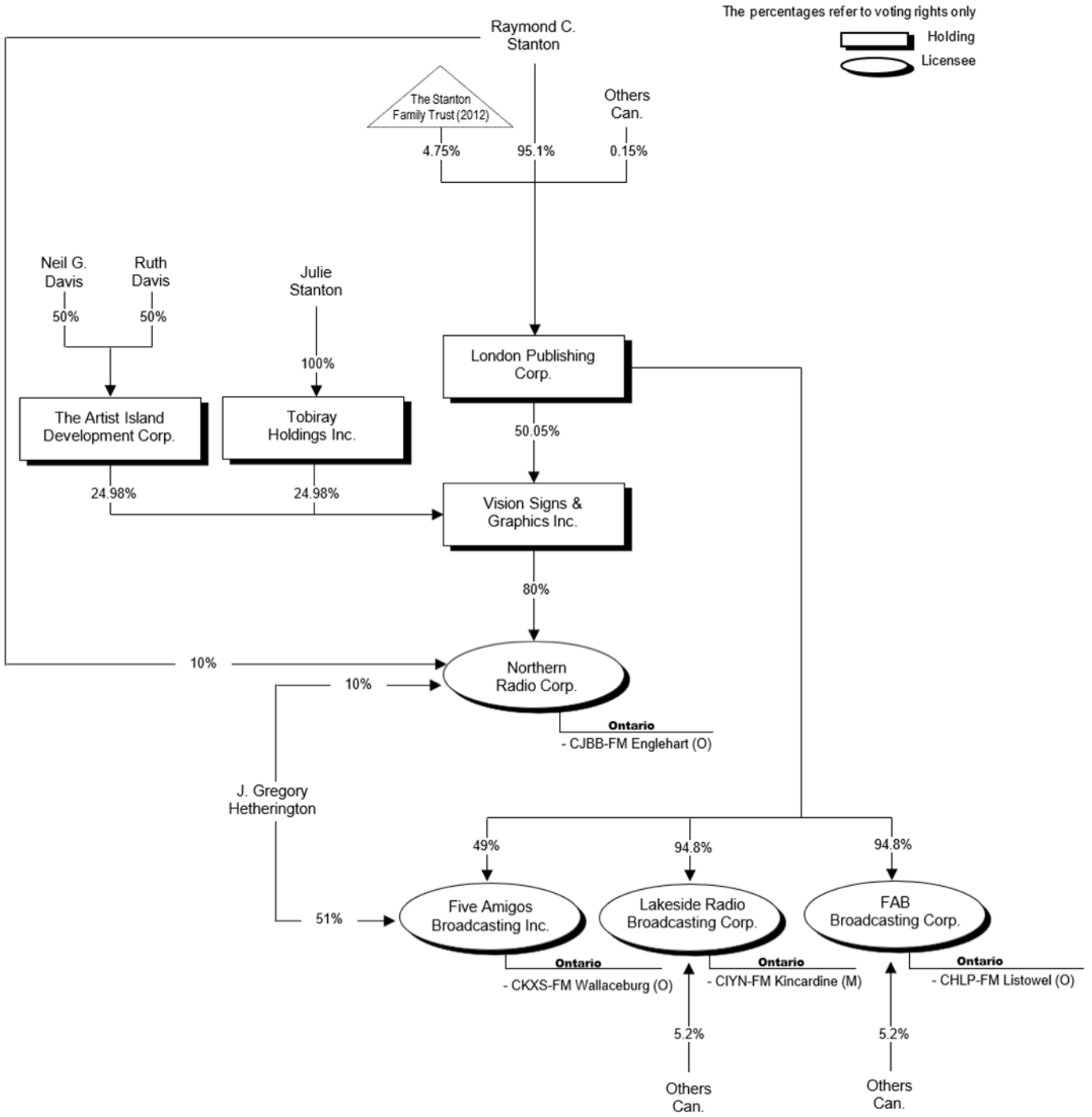


Stanton/Hetherington Radio

UPDATE

Administrative Decision – 2015-05-21 – approved a change in ownership of Five Amigos Broadcasting Inc. from a control by the board of directors to a control by Mr. Gregory Hetherington through the transfer of the 25% voting interest held by Mr. Patterson to Mr. Hetherington thereby increasing his participation to 67.2%. (2015-0301-1)

Administrative Decision – 2018-02-13 – approved a change in ownership of Five Amigos Broadcasting Inc. through the transfer of all of the shares held by Mr. Mike Kilby (32.8%), as well as the transfer of 16.2% of the shares currently held by Mr. Hetherington, to London Publishing Corp. Effective control of Five Amigos will continue to be exercised by Mr. Hetherington. (2017-0981-7)

CRTC 2018-223 – approved the acquisition by Northern Radio Corp. of the assets of the radio station CJBB-FM Englehart from 1353151 Ontario Inc. **NOTE:** *The transaction closed on 8 August 2018.*

CRTC 2019-118 – approved a new FM radio station in Listowel proposed by Five Amigos Broadcasting Inc.

CRTC 2021-214 – approved the acquisition by Lakeside Radio Broadcasting Corp. of the assets of the radio station CIYN-FM Kincardine from My Broadcasting Corporation. **NOTE:** *The transaction closed on 1 September 2021.*

CRTC 2022-13 – approved, as part of a corporate reorganization, the acquisition by FAB Broadcasting Corp. of the assets of CHLP-FM Listowel from Five Amigos Broadcasting Inc. **NOTE:** *The transaction closed on 29 May 2022.*

Update – 2022-09-09 – on 11 March 2020, Northern Newspaper Corp. changed its name to Vision Signs & Graphics Inc.

Update – 2022-10-25 – on 1 January 2019, Boogida Holdco Inc. amalgamated with and to continue as Tobiray Holdings Inc.

Update – 2022-12-31 – minor change.

Update – 2023-12-19 – of the shareholding of London Publishing Corp.

CRTC 2025-306 - Approved an application by FAB Broadcasting Corp., for authority to change the ownership and effective control of the English-language commercial radio programming undertaking operating the radio station CHLP-FM Listowel. At the close of the transaction, London Publishing Corp will be the sole owner of FAB Broadcasting and Raymond Stanton will exercise effective control of the station. **Note:** The transaction closed on November 19, 2025.

CRTC 2025-307 - Approved an application by Lakeside Radio Broadcasting Corp., for authority to change the ownership and effective control of the English-language commercial radio programming undertaking operating the radio station CIYN-FM Kincardine, and its transmitters CIYN-FM-1 Goderich and CIYN-FM-2 Port Elgin, Ontario. At the close of the transaction, London Publishing Corp will be the sole owner of Lakeside Radio Broadcasting and Raymond Stanton will exercise effective control of the station. **Note:** The transaction closed on November 19, 2025.

- 94.8% in Lakeside Radio Broadcasting Corp., the licensee of the undertaking mentioned below.
- 94.8% in FAB Broadcasting Corp., the licensee of the undertaking mentioned below.
- 49% in Five Amigos Broadcasting Inc., the licensee of the undertaking mentioned below. The remaining 51% is held by J. Gregory Hetherington.
